

Non-American Baptist Ordinations

AMERICAN BAPTIST CHURCHES OF OHIO

1. The candidate shall prepare the following documentation:
 - a. Two (2) photocopies of his/her Ordination Certificate. *[It is optional to provide copies of their License];*
 - b. Two (2) letters of character reference. *[One of the two letters must be a letter of ministerial standing from the previous denomination];*
 - c. Ordination Paper (theological statement): The candidate shall prepare a paper following the guidelines that may be obtained from the Region Staff person for the State Advisory Committee on Ordination, or from the ABC/Ohio website, www.abc-ohio.org.
 - d. A copy of his/her college or seminary diploma and/or transcript;
 - e. Indication of which of the three tracks (as listed in the Recommended Procedures for Ordination Manual, available from the Region Office) most closely resembles the previous path to ordination. *[A candidate who is deficient in any aspects within the chosen track must meet those deficiencies];*
 - f. Indication of satisfactory completion of a course in Baptist History and Polity. *[A candidate who has not completed a seminary level course may arrange with the Region Staff person for SAC to secure a tutor to complete this requirement].*
 - g. Completion of a comprehensive career and candidacy assessment program sponsored by or in consultation with an American Baptist related Career Development Center within five years prior to examination by the State Advisory Committee on Ordination. A copy of the report is requested by the candidate to be sent to the Committee (Region Staff Person).
2. The candidate shall meet with an ABC/Ohio Region staff member to review the ABC/Ohio Process for Recognition of Non-American Baptist Ordination.
3. The candidate shall meet with an Association Pastoral Relations Committee whose agenda shall be to understand the following:

<ol style="list-style-type: none">a. Biography;b. Spiritual pilgrimage, including conversion;c. Call to ministry;		<ol style="list-style-type: none">d. Educational preparation for ministry;e. Reasons for desiring entry into the ministry of the American Baptist Churches.

4. After completing steps one and two, the candidate shall seek an appointment with the State Advisory Committee on Ordination whose agenda shall be to do the following:
 - a. Review his/her credentials and Ordination Paper;
 - b. Understand the call to ministry;
 - c. Determine the candidate's understanding and subscription to The Covenant and Code of Ethics for Professional Church Leaders of the American Baptist Churches in the U.S.A.;
 - d. Determine whether or not the candidate has satisfied the requirements for Track I, II or III for recognition of ordination and convey such information to the candidate's local church, region and the official registry of the Ministers Council of the American Baptist Churches USA, Valley Forge, PA.
 - e. Review the candidate's ordination paper.
4. Completion of a comprehensive career and candidacy assessment program sponsored by or in consultation with an American Baptist related Career Development Center within five years prior to examination by the State Advisory Committee on Ordination. A copy of the report is to be requested by the candidate to be sent to the Committee (Adjunct Staff Person).
5. The candidate must enroll with the American Baptist Personnel Services. Upon recognition of ordination, a packet of computer materials for \$25.00 may be obtained from the **American Baptist Personnel Services, P.O. Box 851, Valley Forge, PA 19482-0851.**
